- 6.2 None of the parties shall use the name, logo, likeness, trademarks, image or other intellectual property of either of the other parties for any advertising marketing, endorsement or any other purpose without specific prior written consent of an authorized representative of the other party and the each such use.

**7. JURISDICTION OF THE MOU**

- 7.1 Both parties agreed to solve any problem between themselves and in any unavoidable circumstances the judicial proceedings may be followed.
- 7.2 In case of any disputes the judicial jurisdiction will be the court at Ranchi and the High Court at Ranchi.
